Ticket Cash: This is a cash refund of the Unused Credit or Partial Unused Credit. The amount of the cash refund will be the Unused Credit amount or Partial Unused Credit amount as of September 15, 2023. If you select the Ticket Cash option, your Unused Credits or Partial Unused Credits will be frozen by Delta within 14 days after the Claims Deadline. If you no longer have any Unused Credit or Partial Unused Credit as of September 15, 2023, you will only be eligible to receive Interest Cash or Interest Credit, not Ticket Cash or Ticket Credit.

Interest Cash: If you select to receive Ticket Cash, you will also receive Interest Cash in the form of a cash payment in an amount equal to 7% of the original ticket amount for both Unused Credits and Partial Unused Credits.

Ticket Credit: This is a credit in the amount of the Unused Credit or Partial Unused Credit that must be used by December 31, 2023, for travel no later than December 31, 2024. Please note: If the Judge does not grant approval of the Settlement at the Final Approval Hearing, the deadline to use your Unused Credit or Partial Unused Credit by December 31, 2023, for travel no later than December 31, 2024, will not be extended.

Interest Credit: If you select to receive Ticket Credit, you will also receive an Interest Credit in a credit in an amount equal to 7% of the original ticket amount for both Unused Credits and Partial Unused Credits, valid for one year from issuance.

Multiple Credits: If you have more than one eligible Unused Credit and/or Partial Unused Credit, you can select Ticket Cash and Interest Cash or Ticket Credit and Interest Credit individually for each credit.
